JUST imagine

You live on a fixed income and your landlord has unlawfully raised the rent.

An unexpected health crisis forces your grandfather to rely upon a family member's care, and they start to neglect him.

Your mother fell for a scam and is at risk of losing a lot of money she can't afford to go without.

All of these scenarios are more common than you think. Since 1976, CCSLS has worked to uphold elder rights and voices in our community. By offering free legal services, we provide critical support to seniors who do not have other resources or opportunities to obtain legal aid.

Over the year, we worked with 813 clients who were facing serious legal challenges. Because we focus entirely on senior issues, our staff and volunteers give 100% of their attention to elders in our community, making sure they feel heard, respected, and walk away with a sense of agency.

"We've found that the presence of our CCSLS attorneys can make a tremendous difference in outcomes for our clients. Attorney representation can be a deciding factor in obtaining settlement money or restraining orders, rolling back illegal rent increases, facilitating required accommodations, and in cases when eviction is required, our help can often get more time to create a 'soft landing' as clients transition to different living arrangements. Our advance planning services can give elders peace of mind as they age, knowing their endof-life wishes are in place and will be respected. One cannot always quantify the value of keeping one's home, remaining safe, or having peace of mind."

your impact: SHELTER

Older adults in Contra Costa County face a higher risk of housing instability for several reasons. Many live on fixed incomes, which makes it hard to afford rent increases. Disabilities, like mobility challenges, also make moving especially difficult. These factors can put older adults at risk of homelessness, often for the first time in their lives, when their housing is threatened. Contra Costa Senior Legal Services helps support housing security by assisting clients in keeping their current homes or negotiating for more time to move when needed.

PREVENTED LOSS OF CURRENT HOUSING





We assisted Charles*, a low-income senior with disabilities whose rent wasn't being appropriately calculated.

Our attorney communicated with the housing authority in Antioch, and was able to get Charles' share of the rent reduced to accurately reflect his true and current monthly income.

Now Charles has a more stable living situation and a little more money to live on each month.

your impact: SAFETY

Personal safety is a basic human need. Contra Costa Senior Legal Services promotes personal safety for older adults in our county by helping our clients obtain restraining orders against their abusers. Civil restraining orders can prevent further physical, emotional, verbal and/or financial abuse.

CCSLS assisted Sophia* to obtain and enforce a Temporary Elder Abuse Restraining Order with **an immediate move-out order against her son**, who was abusing her emotionally due to his own alcoholism and mental illness.

Before the hearing, our attorney helped Sophia negotiate a settlement agreement to ensure that the son would obtain extensive mental health treatment and agreed to an immediate move-out if, after he returned home, he reverted to his abuse. This settlement allowed Sophia to remain in good standing with the Homeowner's Association, who had threatened her housing because of her son's abusive behavior.

your impact: SECURITY

Many people, including older adults, struggle to maintain their sense of security and wellbeing. Scammers prowl around elders, looking for ways to separate them from their possessions. Planning for one's future loss of capacity is difficult, as is planning for the end of life. Social Security and other benefits can be confusing and difficult to navigate. Contra Costa Senior Legal Services strives to relieve elders of these burdens by providing vital education, answering questions, and helping elder adults prepare the documents they need. Knowing that your economic situation is secure and that your wishes will be honored gives older adults peace of mind.

CCSLS assisted Ebony,* in obtaining the payment she was awarded against a defendant for failure to return her security deposit. When CCSLS notified the defendant that we were going to subpoena his financial records, the defendant agreed to pay and sent a check to the CCSLS office within two days. After seeking the return of her security deposit for nearly 16 months, Ebony had her \$3,397 check delivered to her in person by our attorney. Upon seeing the check, **Ebony** burst into tears of happiness saying "I never gave up," and "it was wrong for them to take my money."

Ebony was right and the court agreed, ordering the defendant to not only return the security deposit but to also pay bad faith damages.


